The County and O.B.O.s propose to use FY 2024 CDBG Program funds for the following activities:

- □ Borough of Waynesburg = \$93,415
  - General Admin = \$16,814
  - Sewer Relining (Morris & Morgan Streets) = \$76,601
- □ Cumberland Township = \$119,176
  - General Admin = \$21,451
  - Housing Rehabilitation = \$97,725
- □ Franklin Township = \$126,469
  - General Admin = \$22,764
  - Sewer Improvements (Phase 2 Hill School House Rd) = \$103,705

If the County and the O.B.O.s would undertake the acquisition, demolition, and/or rehabilitation of residential properties that could result in displacement of families or individuals, then the County's policy for minimizing such displacement would be in effect. The County is responsible for replacing all low-and moderate-income housing units that may be demolished or converted as a result of the use of CDBG funds.
